## **Christmas Newsletter: December 2022**

Dear Member/Supporter,

Christmas has come around again and I have held off the Newsletter to give us time to see the possible outcomes from the November local body elections.

Well! Wayne Brown for Mayor! Whether you love him or hate him he is facing up to the realities of funding and delivering Auckland's basic operations and development needs. These were obscured by the last two mayors under a smokescreen of Communications stories about ideologies and achievements, visions of emergencies and crises, iconic dreams and promises; and supported by consultants and studies. Growth was funded on rate rises, increased borrowings and Government help and ratepayers were stuck with a general feeling of wasteful spending, lack of value for money, high council overheads, and a general failure to perform and implement projects and basics efficiently and effectively.

We have repeatedly said the current AC structure is not fit for purpose, but it can be made to work better!

Wayne's approach and platform has seen him elected by a significant margin of Auckland voters. The same can be said for our Rodney area where Councillor Sayers has been re-elected again despite competition, and where the pro-rural and non-aligned candidates for the local board achieved a significant majority of the popular vote. Candidates under the Rodney first banner still did well and the balance now means we are looking to see how the new local board members perform on matters which continue to concerns local voters.

Wayne wants to hold down rates, focus on project completion and performance, improve council efficiency, increase delegations in responsibilities down to a local level and reorient priorities to align with what voting rate payers want, rather than with the ideologies of those who purport to know best what voters should have. All of these are fully consistent with what NAG has been fighting for.

Chief among these concerns is the need to do something to fix the regions roads (Rodney's in particular) and balance servicing the interests of rural ratepayers (who have been neglected although they pay half the rates) with those of their urban friends.

Wayne's thinking as expressed to date aligns well with that of our Councillor Greg Sayers who has been a strong supporter of, and advocate for, Rodney ratepayers interests. Chief among these is keeping rates to a reasonable level; fixing Rodney's roads and significantly improving the quality and implementation of the planning for Rodney's infrastructure and facilities.

In the New Year we also look forward to Wayne and Greg addressing and correcting the RFT report; continuing the fight to repeal three (now five) waters; and reviewing council's approach to disposal of residual waste (which currently has them supporting the flawed and strongly contested proposal for a new regional landfill in the Dome valley).

So NAG wants to congratulate our newly elected mayor, councillor and all local board members. NAG will be working to support their efforts to improve the quality of Rodney's governance and improving the outcomes for all Rodney ratepayers.

Of course we must recognise that not everyone will be happy with what decisions get made. Our aim is to get them made as much at the local level as possible. We have not forgotten the merits and strength of the Community Empowerment Model we argued for at the Local Government Commission. Localism and community empowerment is the only way we see to change the attitude of frustration and remoteness that Rodney people feel from being dictated to by an urban centric Auckland Council and its independent service silos.

## **Billboard campaign**

This has been on hold pending the election outcomes and it looks like we will have to change tack! - lending support and credit to initiatives which benefit Rodney's communities. This is a welcome change from the ongoing need to criticise AC and remind people about the poor outcomes for Rodney.

Of course we have not forgotten central government policies and ideologies which are impacting our communities. There will be more to be said about three waters, transport policy, nationalisation, free speech restrictions. and local government and electoral reform as we head into the national election next year.
